FREQUENTLY ASKED QUESTIONS:

1. Are there any charges for GIRO service?

The service is free.

2. When will my bank account be debited?

It will be debited on your Hire Purchase / Operating Lease Agreement due date.

3. How will I know the GIRO is effective?

Depending on your bank, you may or may not receive a notification from them. However, deduction from your bank account will only commence when you receive an email confirmation from us.

4. How long will it take for the GIRO to take effect?

The processing time is usually between 4 to 6 weeks. Please make payments via Paynow or Internet Banking until you hear from us.

5. What if my GIRO is rejected for any reason?

We will contact you via email to inform you of the reason and provide a new GIRO form for your submission. In the meantime, please continue to make payment via PayNow or Internet Banking.
